**2017 Municipal General Election Canvass Report**

Delta City conducted their 2017 Municipal General Election on Tuesday, November 7, 2017. Paper ballots were used for our City's two precincts, #17 North of Main Street, and #18 South of Main Street.

There were 1,519 registered voters within Delta City with 576 ballots cast for a voter turnout of 37.92%.

Mayoral Candidates

John W. Niles received 386 votes for 67.25% of the mayoral votes cast.

J. Travis Keel received 188 votes for 32.75% of the mayoral votes cast.

Council Member Candidates

Randy L. Riding received 196 votes for 19.05% of the council member votes cast.

Kiley J. Chase received 394 votes for 38.29% of the council member votes cast.

Betty Jo Western received 439 votes for 42.66% of the council member votes cast.

Other Election-Related Data

There were two provisional ballots received in precinct #17 and one in precinct #18 for consideration at canvass. One provisional ballot could not be counted, voter was notified, and their provisional ballot served to register them for future elections.

There were two absentee ballots received in precinct #17 and one in precinct #18 for consideration at canvass.


