Mayor Nielson called the meeting to order at 7:30 p.m. and stated that notice of the time, place and agenda of the meeting had been posted at the governing body principal office. Notice had also been provided to the Millard County Chronicle, the Millard County Gazette, and the local radio station, KNAK, as well as to each member of the governing body by personal

delivery. All notices were delivered two (2) days prior to the meeting. Notice of the hearing and the intention to vacate 400 North Street had also been published in the Millard County Chronicle on March 29 and on April 5, 12, and 19, 1984.

Mayor Nielson explained that the purpose of the Public Hearing was to receive public comment regarding the intended street vacation of that portion of 400 North lying east of 350 East in Delta Ctiy. The portion of the street to be vacated is described as follows:

Commencing at the Northeast corner of Lot 4, Block 91, Plat A, Delta Townsite, according to the official plat thereof on file in the office of the Millard County Utah Recorder; thence East 1209.00 feet; thence North 99.00 feet; thence West 1209.00 feet; thence South 99.00 feet to the point of beginning.

Mayor Nielson then asked if there were any comments from the floor.

Robert Pendray reminded the Council that Pendray Development had requested in the past years the vacation of 4th North on several occasions.

First (approximately $2\frac{1}{2}$ years ago), Pendray Development had planned that a trailer park subdivision was to be converted to a home subdivision once the trailer park was no longer needed. Accordingly, a request was made to the City to vacate 4th North so that an appropriate road plan could be used in the subdivision. The request was denied.

Second, $1\frac{1}{2}$ years ago plans were made to build a home subdivision. Once again a request was made to vacate 4th North, and the request was denied by the Council.

After the second denial, Pendray changed the road plan concept within the subdivision. Instead duplexes were built on the north end of the subdivision. It was at that time that the City asked the Pendrays of their interest in accepting the 4th North vacated property. However Pendray's plans were too far along at that point to make a change. Had that not been the case the 4th North property could have been used to a much better advantage than today.

Mr. Pendray told the Council that the portion of 4th North to be vacated and become available to Pendrays would be donated to each home owner along the street.

Mr. Pendray understood with the City Council adoption of the 400 Nroth Streer Vacation Ordinance that Millard County Drainage District #4 would still have the authority to maintain the drain.

Council Member Ruth Hansen questioned the status of the utility lines in the proposed vacated area. Mr. Pendray explained that the utility lines could remain at this time as they are. Further, Mr. Pendray has advised the

utility companies to study the future placement of their utility lines, because of the possibility that the drainage ditch may be moved.
