Mayor Dafoe called the meeting to order at 6:30 p.m. Carol Howell, City Secretary, acted as secretary. Mayor Dafoe stated that notice of the meeting time, place and agenda was posted at the principal office of the governing body located at 76 North 200 West and was provided to the Millard County Chronicle/Progress, the local radio station, KNAK, and to each member of the City Council by personal delivery two days prior to the meeting.

Mayor Dafoe stated that the purpose of the Public Hearing was to receive public comment regarding a proposed ordinance regulating parking in private business parking areas.

Mayor Dafoe explained that there has been a problem with several individuals parking in private parking areas making alot of noise and leaving extreme amounts of litter. In an effort to help solve that problem, the City Attorney has been instructed to draft an ordinance that will allow the enforcement of offenders, and interested private business owners have been asked to enter into an agreement with Delta City for enforcement on their property.

Mayor Dafoe then asked for comments from the public.

Hal Terry, The Cleaners, said that during all hours of the day and night the driveway at The Cleaners is blocked with parked vehicles, which causes an inconvenience for his customers. He also said that there is a considerable amount of litter left behind when they leave.


Mr. John Davies said that he is helping his father-in-law with his business at his trailer park and has complaints against the late hours and loud noises around the trailer park at night.

Paul Pace, Farm Bureau Insurance, said that he would like to go on record as saying, "I am thoroughly disgusted with this situation in the City of Delta as it pertains to this." He said that when he arrives at work, he spends approximately 15 minutes picking up garbage. He has had tire tracks across his grass, sprinklers broken off and broken beer bottles in his parking lot. He said that he is embarrassed to go down the roads through Delta and see what this City looks like.

Attorney Waddingham said that once an ordinance is adopted and all agreements are in place, private property owners will have the right to purchase and post an 18" x 24" sign which could state when parking will not be permitted and that any violators will be issued a citation or towed away. Mr. Waddingham said that violators will be charged with a Class "B" Misdemeanor, punishable from 0 - 6 months and 0 - \$1,000.

Mayor Dafoe asked if there were any comments, questions or items to be discussed. There being none, Mayor Dafoe declared the meeting adjourned at 6:50 p.m.
