#### **NEW BUSINESS**

# BILL KEEL: FLAGS DISPLAYED ON MAIN STREET ON NATIONAL HOLIDAYS

Mr. Keel thanked the Council for the opportunity his scout troop has been given to put up and take down flags on Main Street on holidays. The activity provides a great opportunity to teach patriotism and respect for the flag to young scouts. Mr. Keel noted that their first opportunity to hang flags was the Fourth of July and it appeared that several of the flag holders on the poles were inadequate. Mr. Keel proposed that the Council approve installation of new brackets on the poles along Main Street, at a cost of approximately \$12.00 per pole, which would include removing old brackets and installation of new brackets. Mr. Keel noted that they put up 38 flags on the Fourth of July, but he counted 41 poles which should have flags on them. The total cost for replacing brackets on 38 poles would be \$456.00, and \$492.00 for 41 flag poles.

Council Member Wesley Bloomfield <u>MOVED</u> to approve installation of new flag brackets as requested by Mr. Keel, and approve \$500.00 for the project. The motion was <u>SECONDED</u> by Council Member Robert Dekker. Mayor Roper asked if there were any comments or questions regarding the motion. There being none, he called for a vote. The motion passed unanimously.

# RESOLUTION NO. 2001-275

A RESOLUTION AMENDING RESOLUTION 2001-274, REVISING THE MONTHLY SERVICE CHARGE FOR USE OF THE DELTA CITY WATER AND SEWER SYSTEMS.

Mayor Roper advised the Council that when Resolution No. 2001-274 was passed, there were some items which needed to be clarified. This Resolution amends Resolution 2001-274, and includes those items which were not included in the previous resolution passed at the last meeting of the City Council.

# **OTHER BUSINESS**

Mayor Roper urged Council Members to inform City Recorder Gregory Jay Schafer of what dates they will be attending the Utah League of Cities and Towns to be held September 4-9, 2001.

Council Member Gayle Bunker felt that the Fourth of July parade was very good, but hear comments that parade entries which stop to do performances are spending too much time performing. He suggested that perhaps we need to attempt to limit those performances next year. Council Member Wesley Bloomfield was dismayed to see entries which were advertising only, rather than a display of any type. In addition, Council Member Bloomfield noted a couple of Demolition Derby cars which were being driven rather than being on a trailer. Mayor Roper felt that, over all,

the parade was good.

It was suggested that perhaps some parade guidelines should be formed which would include such items as requiring that entries tie in with the celebration theme rather than advertising only, limiting performances during the parade, and requiring derby cars to be on trailers. Mayor Roper suggested

that the matter be discussed with the Fourth of July Committee in order to have their input.

Council Member Gayle Bunker asked when the new playground equipment will be installed in the park. He was advised that there is some dirt work needed before installation can be done.

Mayor Roper noted that he had received many good comments regarding the new pavilion which has been constructed in the City Park. Mayor Roper suggested that the Council consider build ing another pavilion over the old tennis court on the South end of the City Park. Council Members agreed that we should attempt to have another one constructed before the Fourth of July celebration next year.

Council Member Gayle Bunker reminded the Council that they had previously discussed building an RV dump station. He reported that he had talked to Stephensons, owners of property directly south of the city well property on 300 West, who are willing to sell the property, but have not stated a price as of this time. Council Member Bunker noted that the property is .70 acre and he suggested that the City attempt to purchase the property for the purpose of building an RV dump station at that location. Council Member Bunker requested approval of the Council to make an offer on the property to see if the owners will accept it. Mayor Roper and the Council authorized Council Member Bunker to make an offer on the property.

Mayor Roper asked if there were any comments, questions, or other matters to be discussed. There being none, Council Member Gayle Bunker <u>MOVED</u> to adjourn the meeting. The motion was <u>SECONDED</u> by Council Member Robert Dekker. Mayor Roper asked if there were any comments or questions regarding the motion. There being none, he called for a vote. The motion passed unanimously.

Mayor Roper declared the meeting adjourned at 7:48 p.m.
