A RESOLUTION SUPPORTING
THE OLD CAPITOL ARTS & LIVING HISTORY FESTIVAL

The City Council of the City of Delta, Utah, referred to in this resolution as the "City Council", hereby recites the following as the basis for adopting this resolution:

RECITALS:

WHEREAS, the Eighth Annual Old Capitol Arts & Living History Festival is scheduled to take place on September 10 and 11, 2004, at the Territorial Statehouse Park in Fillmore, Utah;

WHEREAS, the activities scheduled for the Festival include, among other things, living history demonstrations, a judged art show, entertainment by the Bar D Wranglers, a gun show, a Dutch oven cook-off, and children's games and activities, the main purpose of which is to provide the citizens of Millard County with an opportunity to learn more about art and living history and provide a place to display artistic talents and provide historical information and demonstrations;

WHEREAS, the Delta City Council was requested by the organizers of said Festival to issue a resolution that would encourage participation by the citizens of Delta in the activities to be held in connection with the Festival; and


WHEREAS, after considering said request, the City Council has determined to issue this resolution giving its support of said Eighth Annual Old Capitol Arts & Living History Festival.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Delta, Utah:


