



RESOLUTION NO. 06-314

A RESOLUTION ADOPTING A NEW LICENSE FEE SCHEDULE FOR PERSONS OR ENTITIES CONDUCTING BUSINESS IN DELTA CITY.

RECITALS

The City Council of the City of Delta, Utah, (referred to herein as the "City Council") hereby recites the following as the basis for adopting this resolution:

A. Delta City has previously adopted a licence fee schedule for those persons or entities conducting business within Delta City as set forth in Title 9 Section 201 of the Revised Ordinances of Delta City (1981 edition), as amended, entitled "License Fee Schedule."

B. The City Council determined that it was preferable to amend Delta City's ordinances to establish such license fees by resolution in lieu of ordinance consistent with other fee schedules that have been adopted by resolution.

C. On or about December 7, 2006, the City Council adopted Ordinance 06-232, amending Title 9, Section 201, of the Revised Ordinances of Delta City, entitled "License Fee Schedule" by providing that license fees and license fee schedules shall be set by resolution.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Delta, Utah:

Section 1. Adoption of Business License Fee Schedule. Every business, location, trade, calling or profession engaged in a business in this municipality shall be required to pay a fee in accordance with the following fee. Payment of such fee shall be made at the time of filing an application to do business or any extension thereof with the Delta City Recorder at the Delta City offices located at 76 North 200 West, Delta, Utah.



Section 2. Effective Date. This resolution shall become effective January 1, 2007.

Section 3. Repeal of Conflicting Resolutions. To the extent that any ordinances, resolutions or policies of the City of Delta conflict with the provisions of this resolution, they are hereby amended to be in accordance with the provisions hereof.
