RESOLUTION

NUMBER 14-373

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF DELTA, STATE OF UTAH, DESIGNATING CERTAIN DELTA ROADS, STREETS OR HIGHWAYS FOR USE AND OPERATION OF OFF-HIGHWAY VEHICLES AND ESTABLISHING REGULATIONS THERETO.

WHEREAS, the City Council of Delta City, Utah (the "City Council"), through the authority afforded it through Utah Code Ann. § 41-22-1 *et seq.*, has established Section 11-400 of the Revised Ordinance of Delta City (1981 Edition) pertaining to the regulation of off-highway vehicles and designation of certain Delta roads, streets or highways for use by off-highway vehicles and established regulations thereto; and

WHEREAS, Section 11-440 of the Revised Ordinance of Delta City (1981 Edition) provides that certain Delta City streets, roads or highways will be designated by resolution of the City Council as open to off-highway vehicle use and operation.

NOW, THEREFORE, be it hereby RESOLVED by the City Council of the City of Delta, State of Utah THAT:

Section 1. Pursuant to U.C.A. § 41-22-10.5, and Section 11-440 of the Revised Ordinance of Delta City, all Delta City street, roads, or highways under the jurisdiction of Delta City are hereby designated as open to general off-highway vehicle use.

Section 2. To the extent that any section, part or provision of this Resolution is held invalid or unenforceable, such invalidity or unenforceability shall not affect any other portion of this Resolution, and all sections, parts and provisions of the Resolution shall be severable.

Section 3. This resolution shall take effect immediately, as authorized by U.C.A. § 10-3-719.
